- 5. All the information and supporting documents as called for in the various clauses and annexures of the application document should be furnished. The details so furnished should be complete in all respects and as per the formats prescribed. The applicants may have to produce original documents for verification, as and when called for by CMD.
- 6. Any information/clarification required by CMD during or after the empanelment process may be provided promptly.
- 7. Vendors are required to sign and put the seal on each page of Annexure-I, II and duly filled in Annexure-III together with all the supporting documents.
- 8. Vendors should submit all the Annexures without removing any pages. Any alteration, erasure or overwriting will render the document invalid. Alteration is neatly carried out in application forms which are duly attested with the full signature of the vendor however is permitted.
- 9. The properly filled-in application form along with required supporting documents shall be put in an envelope and sealed. The name of the Vendor and the Work / Supplies/Services, for which the Vendor is seeking empanelment, shall be superscribed in neat legible terms.

 - a vendor who is willing to apply for multiple categories must submit separate applications together with other relevant documents.

- 4. The performance of a vendor during the execution of a job/work shall be monitored regularly. In the event of any non-performance/unsatisfactory performance, CMD may take appropriate action including delisting.
- 5. CMD reserves the right to ascertain the credentials submitted, in the manner it deems fit.
- 6. CMD reserves the right to inspect the premises/facilities of the vendors to confirm the authenticity of information furnished/capabilities mentioned in the application.
